


ADDENDUM

12. SELECTION OF CANDIDATES

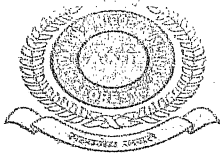


PRESS NOTE
