


**RECRUITMENT OF FOREST RANGER EXAMINATION 2025-26 IN THE**  
**DEPARTMENT OF ENVIRONMENT & FORESTS, ANDAMAN & NICOBAR**  
**ADMINISTRATION.**

The Department of Environment and Forests, Andaman and Nicobar Administration published a Notice of Vacancy dated 25.07.2025 in 'The Daily Telegrams' for recruitment to the post of Forest Ranger. The Written Examination for the post of Forest Rangers was held from 28.12.2025 to 04.01.2026. 

**Detailed Instructions to the Candidates appearing for the Next Phase of  
Recruitment Examination for the post of Forest Ranger  
(Verification of Certificates/Testimonials, Physical Endurance Test & Physical  
Standard Measurement)**

In continuation of the Recruitment Process for the post of Forest Rangers in the Department of Environment & Forests, the Written Examination was conducted during the period 28.12.2025 to 04.01.2026 and upon the recommendations of the Board of Examination, the list of candidates shortlisted for the Next Phase of the Recruitment process has been uploaded in the Web Portal <https://erecruitment.andamannicobar.gov.in/Result.aspx> and <https://forest.and.nic.in> and will be duly notified in The Daily Telegrams.


Further, the shortlisted candidates vide notice as referred to above have been advised to appear in the Next Phase of Examination wherein the Document Verification and Physical Standard Measurements (PSM) are scheduled on 16.03.2026 at the Nature Park and Interpretation Centre (NPIC), Haddo. And the Physical Endurance Test (PET) shall be conducted on 17.03.2026 at the Chidiyatapu Biological Park.

In this regard, all the shortlisted candidates are hereby advised to adhere to the instructions and follow the same scrupulously to avoid rejection of their candidature during the Second Round Examination Process (Document verification, PSM & PET). The detailed instructions to be followed by the shortlisted candidates is as follows:

1. The shortlisted candidates appearing for the Second Round of Examination must furnish an **UNDERTAKING** in the prescribed format stating that the documents/credentials submitted by them during the Document Verification process shall be subject to due verification from the concerned issuing authority so as to ascertain the authenticity/veracity of the documents.
2. All departmental candidates must submit the No Objection Certificate (NOC) so obtained from the Competent Authority in original at the time of Document Verification.
3. All shortlisted candidates must submit the following documents **IN ORIGINAL-**
  - a. Admit Card
  - b. Photo ID
  - c. Age proof (Birth Certificate/ Xth Pass Certificate)
  - d. Caste/Community Certificate issued on or before 20.08.2025 by the A & N Administration (If digitally signed certificates are provided, the veracity of the same shall be verified from the concerned issuing authority)

- e. Bachelor's Degree Certificate in Science or Engineering of any recognized University with the subjects as indicated in the vacancy notice dated 25.07.2025.
- f. Candidates seeking exemption of height standards must produce relevant certificates in original as indicated in the vacancy notice dated 25.07.2025.
4. All shortlisted candidates must also submit self-attested photocopies of above mentioned documents (single copy) with two passport size photographs as affixed on the Admit Card.
5. The shortlisted candidates must report to the Chairman, Document Verification Committee at NPIC, Haddo on 16.03.2026 at 08.00 AM along with all the above mentioned documents for the process of Document Verification and PSM.
6. Similarly, the shortlisted candidates who have successfully qualified the process of Document Verification and PSM, must report to the Chairman, PET at Chidiyatapu Biological Park on 17.03.2026 at 05.30 AM for undergoing the Physical Endurance Test.
7. Before the PET, all shortlisted candidates are required to furnish an undertaking in the prescribed format to the Chairman, PET declaring that they are physically fit to undergo the PET.
8. Non-compliance / non-adherence with any of the above conditions is liable for cancellation of their candidature.
